
















Number of individuals trained









- Sectors are ranked by number of individuals trained in FY 2019

- IT and ITeS sector has cumulatively trained the highest number of candidates, followed by Building, Construction & Real Estate Services, Auto and Auto components



Top 10 sectors based on number of individuals placed








- ☐ Of all the placed individuals, more than 80% are in these sectors

Sector-wise % placed out of total








Ranking of sectors is based on the number of individuals placed

- Highest share in FY2017 and FY2018 was observed in Building, Construction and Real Estate Services sector. In FY 2019, it is seen in IT and ITES sector






Top 10 states based on number of individuals trained












- ☐ Maharashtra has trained the highest number of candidates in each of the three years
- ☐ Andhra Pradesh, which was not among top 10 in 2017 and 2018, was at second place in 2019
- ☐ Uttar Pradesh ranked 4th in 2017 but stood at 10th in 2019

- ☐ Maharashtra's share has fallen over the years though it has had the highest share in each of the three years
- ☐ Telangana, which was among top 10 in FY 2017 and FY 2018, did not figure among top 10 in FY 2019
- ☐ Share of Madhya Pradesh has increased over the years (5% in FY 2017 to 7% in FY 2019)






Top 10 states based on number of individuals placed















Top 10 states based on placed share
















Placement rate among top 10 states

Number of QPs by individuals trained








- Maximum number of QPs correspond to less than 500 individuals trained
- Number of QPs corresponding to 2001-5000 trainings have increased from FY 2017 to FY 2019, while those in the range of <500, 1001-2000 and >10000 fell.

Active, Inactive and New QPs








- All QPs in Auto, Apparel,
 Tourism, Telecom,

- Logistics and Media have a higher share of inactive QPs.
- Only IT and ITES and Gems and Jewellery sectors have new QPs.

- ☐ In 12 out of 20 sectors, majority of QPs are of level 4.
- ☐ IT and ITES sector has the maximum number of QPs (31), among which 15 are of level 7.
- Building, Construction and Real Estate Services and Organised Retail are the only two sectors with QPs of level 1.



Percentage of individuals trained by source of funding (1/4)








- ☐ At least 24% of the total trainings were self-paid among these sectors
- ☐ Apart from BFSI and Agriculture, CSR's role as a funder in all other sectors remains limited
- Industry funded more than 40% of the trainings in sectors Building , Construction and Real Estate Services, Auto and Auto Components and Telecom, but the same was below 12% in sectors IT and ITeS, Healthcare and Agriculture

Percentage of individuals trained by funding source (2/4)








- □ 70% of trainings in Telecom, 65% in Healthcare, 57% in Building, Construction and Real Estate Services, and 49% in Auto and Auto Components were Industry-sponsored

Percentage of individuals trained by funding source (3/4)








- ☐ The share of Industry- sponsored trainings in Healthcare declined from 65% in FY 2017 to 7% in FY 2018

☐ Share of industry-sponsored training in Telecom sector fell from 70% in FY 2017 to 57% in FY 2018 and further to 54% in FY 2019






Training Centre Analysis

- ☐ Most of the TPs have up to 50 centers
- □ LabourNet Services India Private Limited had over 1,000 operational centres in each of the three years (1,911 centers in FY 2019)
- Remaining TPs with over 500 operational centers are Empower Pragati Vocational & Staffing Private Limited, AISECT Skill Mission Society, Skill Tree Consulting Pvt. Ltd., Vidyanta Skill Institute Private Limited, ICA Infotech Private Limited, and IL & FS Skills Development Corporation Limited.



- □ Top 10 sectors based on the total number of people trained over the last three years have been reported. These sectors account for 78% of the total TCs.
- The top 10 states based on total number of operational TCs are Maharashtra, Madhya Pradesh, Chhattisgarh, Kerala, Rajasthan, Uttar Pradesh, Himachal Pradesh, Jammu & Kashmir, Delhi, and West Bengal- in descending order. These states account for nearly 56% of all fixed TCs in FY 2019

Number of TCs in rural and urban areas









