Analysis on profile of Assessors based on data from Skill India Portal as on 31st March 2020





AN OVERVIEW



Key Highlights:

- 70% of certified assessors are concentrated in 10 sectors, with maximum number from Textile, Agriculture, Apparel, Electronics and Retail sector
- 55% certified assessors are between 25 34 years in age, indicating young professionals are working in the assessment space
- 42% of certified assessors have completed their graduation and 22% of certified assessors have completed Certificate courses/ITI/ Polytechnic/Diploma.
- 50% of certified assessors have up to 5 years of industry experience.
 - Average industry experience of certified Assessors across Sectors is 7.05 years and 5.08 years is the median value.
- 69% of certified assessors have up to 5 years of assessment experience.
 - Average assessment experience of certified Assessors across Sectors is 4.69 years and 3 years is the median value.
- Only 12% of the total certified Trainers are females.
- 75% of certified assessors are concentrated in 10 states, with maximum number from UP, MP and Rajasthan. Overall, the North and West Zone has maximum coverage of certified Assessors.


Glossary:

- Registered Assessors: Data of Assessors who have registered their profiles on SIP.
- Certified Assessors: Data of Assessors who have been certified through ToA program and have certificates on SIP
- Active Assessors: Data of Assessors assigned to at least one batch out of 33792 batches (may or may not be certified) includes both PMKVY (since January 2019 on SIP) and fee-based batches available on SIP

SECTOR-WISE ASSESSOR CERTIFICATIONS





- 6 sectors (Textile & Handlooms, Agriculture, Apparels, Electronics, Retail and Logistics) make up 50% of all Assessor Certifications
- We can see a low correlation of batches (PMKVY and fee-based) with the percentage of sector-wise assessor certifications. This could be because of:
 - Multiple certifications for a single assessor an average of 2.9 QP-certifications per assessor
 - In some sectors, to name a few Green Jobs, Infra equipment, Automotive & Media, there is a requirement of better planning of TOA batches in alignment with expected assessments
 - The data of Assessed batches contains PMKVY and fee-based batches only for the limited duration from Dec 2019 March 2020, as available on SIP. The actual Sector-wise percentage of assessments over a longer period may vary.

AGE AND GENDER



- Age-wise analysis of certified Assessors indicate young professionals operating in the assessment space. 54% of certified Assessors are between 25-35 years.
- The gender balance of certified assessors is skewed towards males. Only 11.8% of all certified Assessors are women. This may be due to the ad-hoc nature of assignments and travel to unfamiliar locations.





GOEGRAPHICAL SPREAD




- 75% of certified assessors are concentrated in 10 states, with maximum number from UP, Madhya Pradesh and Rajasthan.
- Lowest percentage of certified Assessors are from North East states (3.54%)
- Most certified assessors are concentrated in the North and West region

Zone-wise Spread of Assessors



- 22% of certified Assessors have done a certificate course/ diploma/ polytechnic/ ITI course



Sector-wise Industry Experience of Certified Assessors (in yrs)





- The Average Industry Experience of all certified Assessors is 7.05 Years




- 80% of all certified Assessors have industry experience ranging from 0 10 years. 50% of all certified assessors have 0-5 years of experience.
- The highest bracket, 14.2% of all certified Assessors have 5-6 years of industry experience

Sector-wise Assessment Experience of Certified Assessors (in yrs)





ASSESSMENT EXPERIENCE



The Median Assessment Experience of all Certified Assessors across sectors is 3 Years
The Average Assessment Experience of all certified Assessors across Sectors is 4.69 Years



69% of all Assessors are coming in with assessment experience ranging from 0-5 years. 22% of all certified assessors have 0-1 years of assessment experience.

CERTIFIED ASSESSORS IN ACTIVE BATCHES



The following graph represents data of 33,792 QP-based batches on Skill India Portal with 4,278 unique active assessors

- The count of Fee-Based batches is 16,220 with an assessor certification percentage of 76.4% (since February 2019)
- The count of PMKVY batches is 17,572 with an assessor certification percentage of 98.8% (since November 2019). Under PMKVY, the sub-schemes and certified assessor compliance rate are as follows:
 - 85.4% of the batches are RPL with a compliance rate of 99.7%*
 - 13.5% of the batches are STT with a compliance rate of 93.5%
 - 1.1% of the batches are **Special Projects** with a compliance rate of **95.7**%
